<p>ITEM 5</p> <p align="center">SUPPLEMENTS AND REISSUES</p> <p>When reference is made in this tariff, or supplements, to other publications for rates or other information, it includes "Supplements thereto or successive issues thereof."</p> <p>Where reference is made in this tariff to items, it includes "reissues" of such items.</p>	<p>ITEM 50</p> <p align="center">DAYS OF OPERATION</p> <p>Routine days of operation for the KXHR are 8:00 a.m. to 8:00 p.m., Monday through Friday. The KXHR observes the following holidays:</p> <p style="padding-left: 40px;">New Year's Day Memorial Day Independence Day Labor Day Thanksgiving Day and Friday following Thanksgiving Christmas Eve Christmas Day</p> <p>Customers requesting service after operating hours, on weekends or observed holidays may do so for an additional switching fee of \$2500.00 per day.</p>
<p>ITEM 10</p> <p align="center">METHOD OF CANCELING ITEMS</p> <p>As this tariff is supplemented, numbered items with letter suffixes cancel correspondingly numbered items in the original tariff, or in a prior supplement. Letter suffixes will be used in alphabetical sequences starting with "A". Example: Item 100-A cancels Item 100. <p>ITEM 15</p> <p align="center">STATION LIST AND CONDITIONS</p> <p>This tariff is governed by Official Railroad Station List OP&SL 6000 Series to the extent shown below:</p> <p>PREPAY REQUIREMENTS AND STATION CONDITIONS</p> <p>(A) For additions and abandonments of stations, and, except as otherwise shown herein, for prepay requirements, changes in names of stations, restrictions as to acceptance or delivery of freight, and changes in station facilities, etc.</p> <p>When a station is abandoned as of a date specified in the above named tariff, the rates from and to such station as published in this tariff are inapplicable on and after that date.</p> <p align="center">GEOGRAPHICAL LIST OF STATIONS</p> <p>(B) For geographical locations of stations referred to in this tariff by station numbers.</p> <p align="center">STATION NUMBERS</p> <p>(C) For the identification of stations when stations are shown or referred to by numbers in this tariff.</p>	<p>ITEM 100</p> <p align="center">FAILURE TO PULL INTERCHANGE</p> <p>The KXHR will assess connecting carrier a charge of \$50.00 per car per day for failure to pull cars offered in interchange.</p>
